Graded Agency:

For FY 19, the U.S Small Business Administration Office of the Chief Financial Officer (OCFO) Acquisition Division was able to meet all subcontracting goals except for two (2). SBA obtained a level of 1.90% for Service-Disabled Veteran-Owned (SDVOSB) a level of 0.10% for Historically Underutilized Business Zone (HUBZone). SBA was not able to meet all the above subcontract goals due to the significant lack of SBA requirements that (1) had subcontracting opportunities available and/or (2) had additional SDVOSB or HUBZone opportunities available. For Fiscal Year 19, there was one (1) acquisition requirement that met the criteria for requiring a subcontracting plan and presented any available subcontracting opportunities. SBA has one of the highest Prime small business goals among federal agencies, which often leave little to no subcontracting opportunities This is a historically repetitive occurrence further challenged by SBA's mission of Small Business support prioritization coupled with the Federal Regulation statutory requirements of FAR 19.702(b) exempting subcontracting plans for small business awards. In the future, SBA Contracting Officers will continue to seek subcontracting opportunities if or when they become available as much as possible.
