- 1. The regular meeting of the IATF was called to order at 1:01 PM on 06/02/2022 Laura Wages, Director, Policy and Engagement, OVBD

 - c. Presentation 1 OVBD Updates on Veterans Business Outreach Centers (VBOC), Interagency Engagements, and Center for Verification & Evaluation (CVE) Transfer Update – Tim Green
 - i. VBOC Expansion:

Provided details on expanding the VBOC program. Currently, there are 22 VBOCs that serve all 50 states. OVBD is looking to expand by 12 to bring the total number to 34 VBOCs that will serve all 50 states and territories.

iii. CVE Update:

Updates regarding CVE transfer and where to find additional program information were provided. As of January 1, 2023, all functions from the VA's CVE will be transferred over to the SBA.

d. Presentation 2 – *IATF Annual Report*: Amy Garcia, Veterans Business Analyst, Policy & Engagement, OVBD. OVBD will be putting together a combined year report to be submitted by the end of FY22. A timeline was provided outlining month to month expectations. The structure and content areas of the IATF Report was emphasized including Background, Recent Highlights, Task Force Activities, Task Force Priority Areas, and Appendices.

3. Member updates:

- a. DOL, Bill Metheny
 - i. Reported on how veterans are doing as workers/employees around the country. An April report came out showing the veteran unemployment rate is down to 3.0 percent. Overall compared that to their non-veteran counterparts at 3.6%. Last April, the unemployment rate was for FY21 was 5.4%; Bureau of Labor Statistics (BLS) is where DOL gets a lot of employment information. Go to www.BLS.gov and type veterans in the search box to learn more about veterans employment status.
 - ii. Hiring Veterans Medallion Program Talked about when and how the program started and explained that by law it is recognized nationally with one common standard, what makes a great employer who attracts, trains, hires, retains veterans. www.Hirevets.gov
 - iii. Homeless Veterans Reintegration Program Grants The Secretary of Labor announced recipients of the next round of Homeless Veterans Reintegration Program Grants. These are grants that go out to organizations that help veterans who are homeless, experiencing homeless or at risk of being homeless, to get into employment. https://www.dol.gov/agencies/vets/programs/hvrp
 - iv. Government Accountability Office recently published a report where they visited DOL, Office of Federal Contract Compliance Program (OFCC). It shows that a number of veteran owned small businesses are great at working with the federal government as contractors and that there are requirements in there that OFCCP enforces and support to make sure that veterans are filling the ranks of these federal contractors.



- b. DOD, Jonathan Wright Discussed DOD goals in terms of hitting the mark for reaching their SDVOSB goal, and was close for making the year end goal. The goal is 2.7% and DOD is only .3% below their goal and he says they are on track. Mr. Wright said that he started looking at all the services in the Syscoms and seeing where they are in terms of hitting goals. Many of them have already exceeded goals in that area.
- c. VA, Cordell Smith on behalf of Sharon Ridley, Executive Director, Acquisition Policy
 - i. Outreach efforts are ongoing to help veterans and exiting service members navigate through all of the processes, and learn how to setup small businesses and how to compete for contracts.
 - ii. VA Events April 21, 2022, the VA hosted 38 service members from the Joint Base Andrews and passed out materials regarding the verification process, what the OSDBU does, and their areas of support and the resources to help them get started.
 - iii. In May 2022, the OSDBU facilitated a business opportunity session with Schneider Electric, LLC. to help attendees learn about energy savings performance contracts for capital improvement projects. Schneider Electric was looking to identify VOSBs that were potential candidates for contracting relationships with relevant past performance area on energy savings. VA also hosted a showcase for VOSBs and trucking industry in early May.

d. GSA, Allen Hill –

- i. GSA sees challenges in NAICS codes sighting that NAICS codes are based on dollar values, not size of the organization.
- ii. GSA is moving forward and focusing on "Polaris" women owned small business and small business pools are going to be service-disabled veteran owned small business pool along with a HUBZone small business pool. The focus is on disadvantage businesses.
- iii. Outreach to the veteran community includes having more engagements to increase awareness of how OSDBU can support not just SBA, but across all the OSDBUs and connect with them to create awareness across all agencies and DoD for veteran opportunities to participate and support the federal government.
- e. OMB, Mathew Blum Discussed the Executive Order on Equity 13985 and the memo that OMB issued at the end of last year on Advancing Equity and Procurement (M-2203) and how they continue to serve as an important springboard for a series of actions that hold the promise of transforming how OMB uses the power of procurement to advance equity. OMB continues to meet regularly with agencies to review strategies that can help to ensure that agencies are achieving their SDVOSB goals as well as their SDV goals.

 - viii. Set-aside policies that have increased particularly the SDV goals to heights, the tradeoff is going to be in veteran owned businesses and women owned businesses. Agencies who might be exceeding their 3% so that they can meet the SDV goals that have been mandated to them.
