



2001 Small Business Profile: OHIO

That the small business sector is as an economic engine indispensable to Ohio's well being is apparent in the *2001 Small Business Profile*, compiled by the U.S. Small Business Administration's Office of Advocacy. The results in this report show that small businesses are job generators and innovators, and that they represent an array of opportunities to the diverse spectrum of individuals in their communities.

Number of Businesses. In 2000, the number of employer businesses decreased by 2.5 percent, and it is estimated that the number of self-employed individuals increase by 3.3 percent. There were 232,755 employer businesses, and nearly 98.3 percent were small (with fewer than 500 employees) in 2000. Self-employed persons were estimated at 342,934 in 2000. Women-Owned Businesses. Women-owned businesses generated \$30.6 billion in revenues, employed 291,361 workers, and constituted 205,000 firms or 26.2 percent of all firms in 1997. The data on women-owned firms are not comparable between 1992 and 1997. (Sources: U.S. Dept. of Labor, Bureau of Labor Statistics, U.S. Dept. of Commerce, Bureau of the Census)

Minority-Owned Businesses. According to the latest (1997) Census data, a total of 49,400 minority-owned businesses represented 6.3 percent of the businesses in the state and generated \$11.1 billion in revenues. Of these, 10,100 were employer businesses employing a total of 92,710 workers. There were 6,400 Hispanic-owned firms; 27,000 Black-owned businesses; 11,400 Asian and Pacific Islander-owned firms; and 5,100 American Indian and Alaskan Native-owned businesses in 1997. (The data on minority-owned firms are not comparable between 1992 and 1997.) Data may not sum to the total because an owner may be a member of more than one minority group. Business Turnover. There were 2.7 percent or 22,290 fewer new employer firms in 2000 than in 1999. Business bankruptcies totaled 1,471 in 2000, an increase of 23.1 percent since 1999, while business terminations amounted to 24,276, an increase of 0.5 percent from 1999. Employment. Small business employment represented 49.3 percent of the state's total employment and firms numbered 210,708 in 1998. Small businesses employed 2,369,038 of the state's 4,806,046 total non-farm private sector workers (Table 1). (Source: U.S. Dept. of Commerce, Bureau of the Census, Statistics of U.S. Businesses)

Small Business Income. The non-farm proprietors' share of small business income totaled \$18.4 billion—an increase of 5.6 percent from \$17.4 billion in 1999. (Source: U.S. Dept. of Commerce)

Finance. Small businesses often rely upon local bank services, and the number of banks within the state has decreased over the last five years. The Office of Advocacy has published banking studies identifying banks within the state that are small-business-friendly. (See Table 2 for the number of banks by asset size.)
