SMALL BUSINESS: BACKBONE OF THE TENNESSEE ECONOMY

The importance of small business to the state of Tennessee is evident in the 1997 Small Business Profile. The findings reported in this year's profile, compiled by the U.S. Small Business Administration's (SBA) Office of Advocacy, clearly indicate the crucial role small businesses play in the state's economy. Not only do small businesses play a vital role as job creators, but their diversity and composition provide the work force with endless opportunities.

Number of Businesses - In 1996, Tennessee had 106,644 businesses with employees; 97.4 percent of the businesses were small businesses (percent based on 1994 data for independent businesses with fewer than 500 workers). In addition to the number of employer businesses, the state also had 212,000 self-employed persons in 1996, for an estimated total of 318,644 businesses.

Small Business Income - The income of sole proprietors and partners rose 5.5 percent to \$9.7 billion in 1996, while wage-and-salary income rose 4.7 percent. Total personal income rose 4.8 percent to \$77.5 billion. The state also exported \$9.3 billion of goods in 1996.

Minority Businesses - According to The National Foundation for Women Business Owners, as of 1996, there were 139,300 women-owned businesses in Tennessee, including part-time firms, employing 262,700 people and generating \$29.5 billion in sales. Between 1987-1996, the number of women-owned businesses, increased 89.9 percent.

According to the latest Bureau of the Census data, the number of Black-owned firms, including part-time firms, increased 43.1 percent from 1987 to 1992, totaling 14,920 in 1992. The number of Hispanic-owned firms, including part-time businesses, rose 189.2 percent during the same time period with 1,602 firms in 1992. There has also been a marked increase in the number of businesses owned by Asian and Pacific Islanders, American Indians, and Alaskan Natives. The number for this group grew from 1,664 in 1987, to 3,026 in 1992, representing an 81.9 percent increase.

Business Turnover - The number of new firms decreased 1.3 percent, while new business incorporations decreased 5.0 percent in 1996. Financial difficulties leading to business bankruptcies increased by 14.3 percent and business failures increased by 34.1 percent during 1996.

Finance - An SBA Office of Advocacy study found that the number of banks in Tennessee decreased from 250 in 1994 to 238 in 1996. The study also found the top lenders to small businesses in fiscal year 1996 were:

Job Growth - Small businesses created 311,924 of the 366,190 net new jobs from 1992 to 1996. Very small businesses (< 20 employees) created 59.7 percent of the small business growth with 186,176 new jobs. These numbers clearly reflect the importance of small businesses as job creators.

Industries - The composition of small business in Tennessee is very diverse. The Health Services industry is the largest small business employer in Tennessee, followed by Eating & Drinking Places. The fastest growing industry for small business is Miscellaneous Manufacturing Industries (represents industries that were at least 0.25% of the 1994 total).

The following three tables provide further information about the composition of the small business sector in the state. The information is for 1994, the latest year available.
